

MEMO FOR INTERNATIONAL STUDENTS

On your arrival in France, and after registering at your higher education institution, follow these steps to obtain coverage of your health costs throughout the duration of your studies:

REGISTER AT THE WEBSITE: ETUDIANT-ETRANGER.AMELI.FR



Enter the **mandatory** information

- Surname
- Forename(s)
- Date of birth
- Country of birthEmail address
- Postal address in France
- Telephone number

Submit the **mandatory** supporting documents

- Passport/identity card
- Residency permit
- Full copy of your birth certificate/excerpt of birth certificate with parentage (drawn up by the Consulate)
- Certificate of education for the current year
- Certificate of parental permission (under the age of 16)
 - IBAN
- Additional documents according to country of origin

Registration for Health Insurance is **free of charge and mandatory**. It means your health costs will be covered throughout the duration of your studies.

Your registration for Health Insurance

When you arrive in France, and after having obtained your certificate of enrolment in a higher education institution, you must register at the dedicated **Health Insurance** website etudiant-etranger.ameli.fr. You will have to provide the mandatory information and submit the requested supporting documents.

Browse the website before registering here.

Your documents to bring to France

Before you arrive in France, make sure you have the following documents in digital format:

- Evidence of civil status
- Evidence of identity (passport, identity card, etc.)
- Student visa

After you arrive in France, you will also need the following to register for Health Insurance:

- Certificate of enrolment for the current university year, provided by your institution
- Residency permit, provided by the Prefecture

Obtain all of these documents as soon as possible so you can quickly finalize your registration.

You are an international student and you are registered for Health Insurance

As a reminder, registration for Health Insurance is **free of charge and mandatory**. It means your health costs will be covered throughout the duration of your studies.

Your healthcare procedures to be quickly and properly reimbursed

Once you have registered for Health Insurance, and to guarantee proper coverage of your health costs, you must carry out the following procedures:

- Declare your <u>attending physician</u> to ensure better medical monitoring and be better reimbursed. He or she will offer you appropriate care and refer you to a specialist if needed.
- Take out complementary health insurance to top up the Health Insurance reimbursement. If you are on a low income, the Health Insurance may help you with the Complémentaire Santé Solidaire.
- Order your Vitale card when you receive the Vitale card form. The Vitale card must be presented at your medical appointments. It contains all information necessary for reimbursement of your healthcare costs, and coverage if you are hospitalized.
- Open your ameli account on the ameli app (download in <u>Google Play</u> or <u>App Store</u>) or at <u>ameli.fr</u> to track your reimbursements, update your personal information, and access all online services.

If you encounter any difficulties in registering for Health Insurance, contact 3646 (free service + cost of call) Monday to Friday from 08:30 to 17:30. On request, you will be put in touch with a telephone advisor who will talk to you in English, and you may be offered a meeting.
